Bluegrass Products LLC ("Bluegrass") in respect of Mounts, Vents and Shutters, manufactured by it (hereinafter referred to as "Products") warrants to you the original purchaser of Products installed at the property with the above address (the "Property"), that subject to the terms and conditions herein contained, the Products are and will be free from manufacturing defects which result in peeling, flaking, chipping, splitting or blistering.

All manufacturing defects to Products covered by this warranty will be repaired, replaced or restored by Bluegrass in accordance with the terms and conditions of this warranty. Bluegrass shall not be liable for, and this warranty does not apply or extend to, any failure, defects or damages arising from or connected with, without limitation the following: misuse; neglect; faulty or improper installation; owner failure to provide reasonable and necessary maintenance to prevent an accumulation of surface dirt, staining or mildew; exposure to harmful chemicals; failure of or damages to walls, surfaces or structures to which Products are applied arising from settlement, movement, or cracking thereof; distortion or warping due to unusual heat sources (including outdoor grills and reflection from windows or foil sheathing); earthquakes, hurricane, tornado, cyclone, gale, lightning, fire, flood and other naturally occurring catastrophes; accidental or intentional damage; vandalism and all other causes beyond the manufacturer's control.

Bluegrass and its representatives are not qualified to approve, recommend or advise as to the suitability of this product for possible applications. Your local building code authority and fire marshal's office should be consulted as to its safety for its intended use.

COLOR COVERAGE

IMPORTANT: Some degree of fading over time is expected. Products that experience color change due to normal weathering are excluded from this warranty. Non-uniform color change as a result of equal exposure to sunlight is covered under this warranty; however, non-uniform color changes resulting from unequal exposure to sunlight are not covered under this warranty.

Bluegrass, at its sole discretion, shall determine whether the Products are suffering from normal weathering.

This warranty becomes valid only after the Dealer fills in the certification of installation, signed by the original purchaser of the Products and mailed to Bluegrass within thirty (30) days of installation.

This warranty is non-transferable.

Should you feel that the Products contain manufacturing defects, promptly write to the Customer Service Department, Bluegrass Products LLC, 7930 Kentucky Dr., Florence, KY 41042, describe the claimed defect and provide proof of ownership of the Property. Do not undertake repairs without receiving advice from Bluegrass, as improper repair work may aggravate the problem. Upon receipt of your letter, Bluegrass will notify you of the evidence you will need to support your claim.

Upon verification of the claim, Bluegrass will provide the original purchaser the material necessary to replace the defective Products. Bluegrass reserves the right to discontinue or change any of its Products, including colors, without giving notice to the original purchaser. In the event of such discontinuance or change, Bluegrass shall not be liable to the original purchaser. Should an accessory covered by this warranty be unavailable, Bluegrass reserves the right to substitute a Product that is of equal quality or price, according to Bluegrass's sole discretion.

Bluegrass shall not be liable for inconvenience, labor, loss of time, maintenance, removal or reinstallation of the Products or other incidental, special or consequential damages arising in relation to the purchase or use of the Products.

THIS WARRANTY IS GIVEN IN LIEU OF ALL OTHER WARRANTIES, LIABILITIES OR OBLIGATIONS OF BLUEGRASS, EITHER EXPRESSED OR IMPLIED, EXCEPT THAT THE DURATION OF ANY IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE LIMITED IN TIME TO THE DURATION OF THIS WARRANTY.
